BEST PRACTICE STANDARDS

EFQM Leaders for Excellence and Assessor trainings held

MUSCAT: EFQM Leaders for Excellence and EFQM Internal Assessor trainings were conducted recently in Muscat by Dr Karl J. Koller, director of the Swiss Institute for Total Quality Management (ITQM), Zurich, Switzerland.

Executives and quality management specialists from various Omani government organisations such as the Ministry of Health, the Ministry of Higher Education, the Ministry of Defence, the Institute for Public Administration, the Sultan Qaboos Hospital, the Oman Specialised Nursing Institute, the Telecommunications Regulatory Authority attended the trainings, says a press release.
